Opening Business

Principal Report, Martha

- The Reverse Parade was a lot of fun. Thank you for working on the Jog-a-Thon.
- Wednesday the 28th at noon, will have a meeting in the library about re-doing the library for the next round of the Bond. Would like more input if anyone would like to share.
- Shade structures look amazing.

School Board Report, Nancy Cobb

- The board approved requesting the waiver application.
- Also approved for the high school to begin using the field for conditioning purposes. The target date is October 26. That also means we will open the track for the general public from 5:30-7:30am
- Starting to re-open school properties
- Also approved starting special education assessments. First round took place last Saturday at Center St. Will move as quickly as we can to begin serving those students, hopefully in person

Presentation, Dr. Dylan Farris and Ali Rabiei

- Here to seek support for waiver application that would allow us to bring back students in TK-2 grade. Presentation shared on plan for re-opening campus
- The period of review takes several weeks. Best case scenario timeline is November 30
- No longer see the hybrid model as viable. Back to the drawing board about what it would look like.
- We will notify the school if there is ever a positive case. Will commit that if a student or staff member has a confirmed case and have been on campus within contagious period, will provide a notice home to families about that.
- Getting feedback on too much screen time. New schedule inspired by other counties that have re-opened. Every student on campus 4 days a week. Students with the live instruction in the morning would then do asynchronously in the afternoon, then the asynchronous in the morning would be in person in the PM. Meets required instructional minutes
- Discussion:

- TLC is expected to have space
- The reason for staggered starts is to take temperatures, etc. to get everyone in safely. Unfortunately, it will be challenging for kids to have kids in multiple grades. Will only let kids in by grade level.
- Is it possible to change from full distance to in-person and vice versa? The answer is, it depends, we want to take care of everyone as much as we can. I think we can more easily make changes at semester than November 30. Would like people to hold off at semester, even at semester with those types of changes will potentially have to re-constituting classes. Nothing is a hard no, but no promises
- If liability goes and we were to sign a letter of support, would it extend to person liability? I would not believe it would go to personal liability.
- Specific cohort of 12 students and 2 adults. Could have more adults, but any more adults than the 2 take up a student spot. Teacher cannot see more than 2 cohorts. This works well with K2 groups
- Lab-confirmed tests. If we have anyone that presents with symptoms, they follow same process as someone with lab-confirmed test.
- We have aging HVAC equipment. Instructing to leave windows open. To put those type of filters in is very taxing on the units themselves and MERV-15 are not viable for these units. We are doing the best we can to upgrade filter to the degree they can handle them and asking for twice as often filter replacements.
- What level of cases would cause school to go all virtual again? If there are 2 cases, County would investigate and if more than 2, considered a cluster.
- If there are more than 24 kids in a class, can there be 13 kids and one teacher?
 No.
- Are most teachers on board with returning if waiver is approved? Did survey, and most are supportive. There are some that are not comfortable.
- o How would school handle eating? In this model, they would not eat at school.
- If a family member tests positive, the student would be quarantined at home due to a confirmed exposure. However, people his son had interacted with would not have to quarantined unless he was confirmed positive.
